



Dear Elliot Families,

It is a joy to us that you are planning to enroll your student here at JECHS for the current school year. This letter serves to provide information about our tuition assistance policy. If you are inquiring for financial aid, you will need to read and understand the information found in this document and then submit your completed application after student is registered.

Program Overview:

The Elliot Tuition Assistance Program of JECHS is designed to help any qualified students who are committed to academic excellence, to growing in faith and leadership, and who desire to actively participate in extra-curricular activities offered.

ETAP is not a scholarship program and is not awarded based on merit. ETAP is designated solely for *tuition reduction* and may not be applied toward school, club, or athletic **fees**. Award decisions shall be based upon financial need or any unusual financial burdens. Tuition assistance is granted on a one-year basis and is not guaranteed for future years. **A new application must be submitted each year.** JECHS offers no promise of continued assistance for future years. ETAP assistance cannot be combined with any other discounts offered by JECHS.

Application Process:

Applications for financial assistance must be submitted each academic year by the deadline to be considered for the following school year. A non-refundable application fee of \$ 35.00 must be submitted with the application. Any previous outstanding balances must be paid in full before an application for tuition assistance may be submitted and considered.

If an application for tuition assistance is denied prior to the start of the school year, the family may request that their enrollment and other fees be refunded based upon hardship.

If a student withdraws or is expelled from school during the year, all unused portions of tuition assistance will be retained by JECHS.

Criteria for continued participation:

- Family account remains current
- Completing parent volunteer hours
- Good conduct, attendance, and a 2.0 GPA (no F's)

JECHS believes that every family is capable of making a sacrifice and financial contribution to attend the school. Tuition assistance and the admittance process are mutually exclusive. Tuition assistance is only considered after the enrollment process has been completed. Tuition reductions will not exceed 25% of the annual tuition.
